Why am I receiving this Notice of Internet Availability?

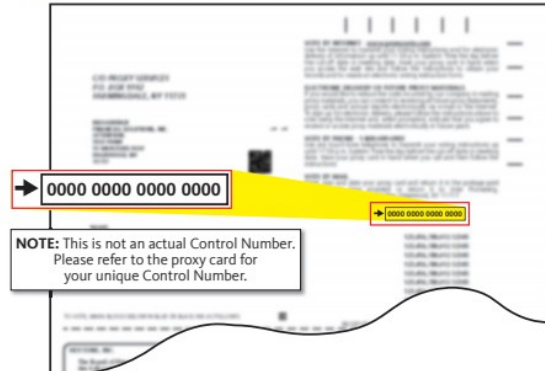

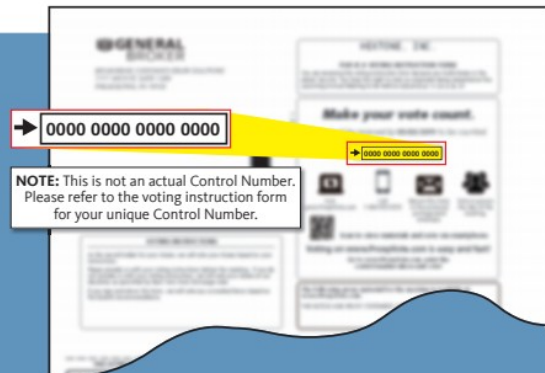
